WHEREAS, the amount to be raised by taxation to support the district budget, shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District No. 1 has taken into account the assessed valuation of taxable property in the Fire District No. 1,

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of theFire District No. 1, at an open public meeting held on December 20, 2012, that the Annual Budget, including appended Supplemental Schedules, of the Borough of Jamesburg Fire District No. 1 for the fiscal year beginning January 1, 2013 and ending December 31, 2013 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Fire District No. 1's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Borough of Jamesburg Fire District No. 1 will consider the Annual Budget for adoption on January 17, 2013.



WHEREAS; In New Jersey poker is considered gambling and gambling is illegal unless played in an established and licensed facility such as the Atlantic City Casinos; and

WHEREAS; The public trust reposed in volunteer firefighters and the Board of Fire Commissioners as an agency of local government requires strict adherence to the Laws of this State.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Fire Commissioners of Fire District No.1 Borough of Jamesburg that poker games and other forms of illegal games of chance are prohibited in any property owned, operated or insured by the Board of Fire Commissioners.

RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS FIRE DISTRICT NO.1 BOROUGH OF JAMESBURG AUTORHIZING EXECUTION OF FINANCING AGREEMENTS BY THE CHAIRMAN AND/OR CLERK OF THE BOARD

WHEREAS; The Board of Fire Commissioners is a duly constituted subdivision of municipal government of the State of New Jersey organized and operating in accordance with the provisions of N.J.S.A. 40A: 14-70 et. seq.; and

WHEREAS; Pursuant to applicable law, the Board of Fire Commissioners is authorized to acquire, dispose of and encumber real and personal property, including, without limitation, rights, and interest in property, leases and easements necessary to the functions or operations of the Fire District; and

WHEREAS; The Board of Fire Commissioners hereby finds and determines that the execution of one or more Master Lease-Purchase Agreements ("Leases") in the principal amount not exceeding \$273,431.00 for the purpose of acquiring the property ("Equipment") to be described in the Leases is appropriate and necessary to the functions and operations of the Fire District; and

WHEREAS; Pierce Manufacturing Inc. or its assignee, if any ("Lessor") shall act as Lessor under said Leases.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Fire Commissioners of Fire District No.1 Borough of Jamesburg as follows:

- Either the Chairman Or Clerk of the Board of Fire Commissioners (each an "Authorized Representative") acting on behalf of the Board is hereby Authorized to negotiate, enter into, execute, and deliver one or more Leases in substantially the form set forth in the document presently before the Board, which document is available for public inspection at the office of the Board of Fire Commissioners. Each Authorized Representative acting on behalf of the Board is hereby authorized to negotiate, enter into, execute, and deliver such other documents relating to the Lease as the Authorized Representative deems necessary and appropriate. All other related contracts and agreements necessary and incidental to the Leases are hereby authorized.
- Section 2. By a written instrument signed by any Authorized Representative, said Authorized Representative may designate specifically identified officers or employees of the Board of Fire Commissioners to execute and deliver

agreements and documents relating to the Leases on behalf of the Board of Fire Commissioners.

- Section 3. The aggregate original principal amount of the Leases shall not exceed the amount stated above and shall bear interest as set forth in the Leases and the Leases shall contain such options to purchase by the Board as set forth therein.
- Section 4. The Board of Fire Commissioner's obligations under the Leases shall be subject to annual appropriation or renewal by the Governing Body as set forth in each Lease and the Board's obligations under Leases shall not constitute general obligations of the Board or indebtedness under the Constitution or laws of the State.
- Section 5.
